NEBOSH Resources

If you are studying for a NEBOSH qualification, we would like to remind you that guidance from NEBOSH is available in the following publications, which can all be accessed from the 'Qualifications' area of the NEBOSH website (under 'Resources' for each relevant qualification):

• NEBOSH Scenario-Based Assessments: Guidance for Learners

This provides guidance on Scenario-Based Assessments for NEBOSH qualifications. It gives examples of extracts from past scenarios, types of questions and how marks would be awarded for answers.

NEBOSH Certificate Scenario-Based Digital Assessments: Learner Guide

This gives guidance on the Open Book Examinations for Certificate Units NG1, IG1, CN1, Cl1, FSC1 and EMC1. Its aim is to help learners prepare for the digital assessment and the closing interview.

NEBOSH National and International General Certificates in Occupational Health and Safety Assessments:
 Learner Performance Report May 2023

This uses the May 2023 Unit NG1 Open Book Exam as an example. It gives advice on the kind of answers that would attract marks and those that would not and guidance on how to approach similar questions that you could expect to see in future papers.

• Diploma Digital Assessment: Learner Guide

This gives guidance on the digital assessments for Diploma Units DN1, DI1, DN2, DI2, DN3 and DI3. Its aim is to help learners prepare for the assessment and the professional discussion.

(Note: not relevant to any other Diploma units.)

Guidance on command words used in learning outcomes and question papers – Certificate qualifications
 This gives definitions of command words and example responses to everyday scenarios and typical exam questions.

(Note: not relevant to Units NG1, IG1, CN1, CI1, FSC1 or EMC1.)

• Guidance on command words used in learning outcomes and question papers – Diploma qualifications
This gives definitions of command words and example responses to typical exam questions.

(Note: not relevant to Units DN1, DI1, DN2, DI2, DN3 or DI3.)

We strongly recommend reading the guidance referred to above that is relevant to the units you are studying, as part of your preparation for the assessments.

Note

NEBOSH use the following terms in relation to their assessments - we thought it would be useful to clarify what RRC see these as, so we can put your mind at ease, as it could be a little confusing:

- **Digital assessment**: the way the assessment is delivered and completed is entirely electronic, meaning you download the assessment paper and submit it electronically using the NEBOSH platform.
- **Scenario-based assessment**: this is the style of the assessment. It uses a scenario which you need to read, refer to and rely on when answering the questions/completing the tasks in the paper.
- **Open book exam**: this is the format of the assessment. An open-book exam, as you know, allows you to refer to resources and notes while you are completing the paper.

RRC Health and Safety Law and Case Law Guide

We have updated the Health and Safety Law and Case Law Guide in relation to some recent legislation. If you are studying a national (UK) course, please note the changes below.

Building Safety Act 2022

In this entry, under the subheading **Changes to the Regulatory Reform (Fire Safety) Order 2005**, the text has been amended to read as follows:

"These are covered in Section 156 of the **Building Safety Act 2022**. Small consequential changes are made to the wording of Articles 5 (*'Duties under the Order'*), 9 (*'Risk assessment'*), 11 (*'Fire safety arrangements'*) and 22 (*'Co-operation and co-ordination'*). The following new Articles are added:

- '9A Risk assessment: assistance'.
- '21A Provision of information to residents of domestic premises'.
- '22A Provision of information to new responsible person'.
- '22B Co-operation with accountable persons'.

NOTE: These changes to the **Regulatory Reform (Fire Safety) Order 2005** (with the exception of Article 9A) came into effect on 1 October 2023.

Article 22B applies to premises consisting of or including a residential unit in a higher-risk building. It requires Responsible Persons to take reasonable steps to identify any Accountable Person(s) in the building (e.g. owners or lessees with a 'relevant repairing obligation') and co-operate with them for the purpose of carrying out their respective duties to collectively manage building and fire safety for the entire building. The purpose of this requirement is to ensure that the duties of Responsible Persons and Accountable Persons will contribute towards a whole-building approach to building and fire safety."

Fire Safety Act 2021

The Notes at the end of this entry have been removed as the whole Act is now in force.

RRC Environmental Law and Case Law Guide

We have updated the Environmental Law and Case Law Guide in relation to some recent legislation. If you are studying a national (UK) course, please note the changes below.

Energy Savings Opportunity Scheme Regulations 2014

In this entry, the second paragraph has been amended to read:

"Minor amendments to Schedule 1 of the Regulations have been made by the **Energy Savings Opportunity Scheme** (Amendment) Regulations 2015 and 2023. These have been included in the text below where relevant."

Under the subheading Part 4 – ESOS Assessments, the text has been amended to read:

"Sets a requirement for a responsible undertaking to carry out an assessment of energy consumption (or for areas where it has already identified significant areas of energy consumption that account for no less than 95% of total energy consumption) in every compliance period. The first compliance period ends on 5 December 2015 and all other compliance periods are four years in duration.

The audit is required to analyse the participant's energy efficiency and recommend reasonably practicable ways that energy efficiency improvements can be made. Audits are to be carried out, supervised or reviewed by an approved assessor (who must meet competence requirements enforced by a professional body)."

Environmental Civil Sanctions (England) Order 2010

In the opening paragraph of this entry, the first bullet point has been amended to read:

• "Variable monetary penalties - the amount is determined by the regulator but must not exceed £250,000 in Wales whereas no cap is present in England."

Environmental Permitting (England and Wales) Regulations 2016

In this entry, under the subheading **Regulation 39: Penalties**, the following has been added:

"Enforcement Undertakings and Variable Monetary Penalties (both civil sanctions) may be issued."

Unit NG1 Element 1

In Scotland the maximum punishment in the Sheriff Court is normally a fine of £20,000 and 12 months' imprisonment. However, unlimited fines and two years' imprisonment can be imposed under the 'Solemn' procedure.
