"The DEFRA publication, *Guidance on the Legal Definition of Waste and its Application*, provides an updated approach to identifying what can be classed as a waste. It achieves this by setting criteria in two parts:

- whether a substance or object has become waste; and
- when wastes should be considered to have ceased to be waste."

Main Exemptions from Waste Operation Permitting

At the end of this subsection, after the paragraph headed "**Northern Ireland**" and before the subheading "**Waste Restriction in Scotland**", please insert the following new subsection:

"Waste Restrictions in England and Wales

Under the Waste (England and Wales) Regulations 2011 (as amended) the following requirements have been set:

- Waste paper, metal, plastic or glass must be collected separately by establishments or undertakings from 1 January 2015.
- All waste collection authorities must make arrangements for the separate collection of waste paper, metal, plastic or glass.
- For both the above an exemption to separate collection is when the collection is not technically, environmentally or economically practicable or when it is not necessary to ensure recovery."

Nitrate Vulnerable Zones (NVZs)

"The **Nitrate Pollution Prevention (Amendment) Regulations 2012** further amend the 2008 Regulations by requiring the Environment Agency to make recommendations to the Secretary of State regarding the designation of NVZs. The Secretary of State must also publish proposals with regard to the Environment Agency recommendations for designating NVZs - informing occupiers of holdings in those areas. A right of appeal for holdings in designated areas is also introduced."

Legislation Applying to the Control of Pesticides

Duties under the Food and Environment Protection Act 1985 and the Control of Pesticides Regulations 1986

Immediately below the Topic Focus under this heading, please insert the following new subsection:

"Sustainable Use of Pesticide Laws

Directive 2009/128/EC on the Sustainable Use of Pesticides includes provisions related to achieving the sustainable use of pesticides. The key requirements include development of national action plans; mandatory test of application equipment; training; operator, adviser and distributor certification; ban on aerial spraying (with some limited exemptions); provision for water protection and sensitive sites; reduction of risk with regard to storage, handling and disposal; promotion of low input regimes (integrated pest management).

The **Plant Protection Products (Sustainable Use) Regulations 2012** have been developed to implement the Directive in the UK. With the UK already having a strong framework for the regulation of pesticides, in practice little will change from the current plant protection products (PPPs) regime. Certificates already issued will remain valid until November 2012; after

this time, certificates relevant to vertebrate control products or for food storage purposes will not be valid. Some of the key requirements of the new Regulations include:

- Development of a National Action Plan for PPPs.
- UK Competent Authority (UKCA) to designate bodies for the implementation of certification schemes and application equipment.
- Prevent the use of professionally authorised PPPs unless the user has a specified certificate or works under supervision.
- Distributors and end users required to have staff to provide information at the point of sale.
- Prohibition of aerial spraying unless in possession of an aerial spraying permit; and pilot and permit holder required to comply with certain conditions.
- Reasonable precautions to be taken for storage, handling and mixing of PPPs."

Reduction of Energy Use and Carbon Emissions

International and National Control Strategies for Carbon Dioxide Emissions

National Control Strategies

In this subsection, please delete the existing text from "Directive 2002/91/EC on Energy Performance of Buildings" to "(also known as asset rating)." and substitute the following:

"Directive 2010/31/EU on Energy Performance of Buildings

Key requirements of the Directive include:

- An energy performance certificate (EPC) is required to be produced when a building is sold, constructed or rented out.
- A display energy certificate (DEC) must be produced annually for public buildings greater than 1,000m². This shows the running costs of the building and must be displayed in a prominent place.
- Regular inspections of air-conditioning systems with an effective rated output of more than 12kW.
- Inspections of heating systems over 20kW."
