### **NEBOSH Resources**

#### Note

NEBOSH use the following terms in relation to their assessments - we thought it would be useful to clarify what RRC see these as, so we can put your mind at ease, as it could be a little confusing:

- **Digital assessment**: the way the assessment is delivered and completed is entirely electronic, meaning you download the assessment paper and submit it electronically using the NEBOSH platform.
- Scenario-based assessment: this is the style of the assessment. It uses a scenario which you need to read, refer to and rely on when answering the questions/completing the tasks in the paper.
- **Open book exam**: this is the format of the assessment. An open-book exam, as you know, allows you to refer to resources and notes while you are completing the paper.

### **RRC Environmental Law and Case Law Guide**

We have updated the Environmental Law and Case Law Guide in relation to some recent legislation. If you are studying a national (UK) course, please note the changes below.

#### United Kingdom Withdrawal from the European Union

News

At the end of this entry, the following new paragraph has been added:

"The **Retained EU Law (Revocation and Reform) Act 2023** allows for the amendment of retained EU law (REUL), so that laws that are appropriate to the UK will remain in the legal system. Its powers allow for REUL to be revoked, replaced, restated or amended."

#### Environmental Offences (Fixed Penalties) (England) Regulations 2017

In this entry, the first paragraph has been amended to read:

"These Regulations state the ranges of fixed penalties that can be issued by local authorities. They cover issues such as littering, free distribution of printed matter on designated land and graffiti and fly-posting. The range is not less than £65 and not more than £500 (fines changed by the **Environmental Offences (Fixed Penalties) (Amendment) (England) Regulations 2023**)."

#### **Environmental Permitting (England and Wales) Regulations 2016**

In this entry, at the end of the section headed **Introduction**, the following new paragraph has been added:

"The Environmental Permitting (England and Wales) (Amendment) (England) Regulations 2023 make changes to the regulations covering a broad range of areas. Key changes include:

- Adding to the definition of mobile plant.
- Requiring the following of general binding rules for small-scale sewage discharges.
- New definitions for mobile plant (part B mobile plant, waste mobile plant, mobile medium combustion plant and groundwater mobile plant).
- Closed loop ground source heating/cooling systems and low environmental risk burials at new cemeteries or new extensions to cemeteries are exempt from an environmental permit."

#### **Environmental Protection Act 1990**

In this entry, under the heading **Section 34A: Fixed Penalty Notices**, the second paragraph has been amended to read:

"Fixed penalty notices may be served where a person has failed to comply with a duty to furnish documents. Once the fixed penalty has been accepted, proceedings cannot be instigated for prosecution."

#### Environmental Protection (Microbeads) (England) Regulations 2017

In this entry, the fourth and fifth paragraphs have been amended to read:

"Non-compliance with the Regulations can lead to a civil sanction such as a fixed monetary penalty of £200 or £100 if paid within 28 days (added by a later amendment), stop notice, compliance notice and enforcement undertakings (Regulation 7). Failure to comply with a stop notice is an offence (Schedule). Appeal relating to a civil sanction is to a first-tier tribunal.

Regulators can recover the cost of enforcement for the issue of a fixed monetary penalty, compliance notice or stop notice (Schedule). The Regulations give enforcement officers the powers to carry out investigations into non-compliance with the Regulations (Regulation 8)."

#### Environmental Protection (Plastic Straws, Cotton Buds and Stirrers) (England) Regulations 2020

In this entry, in the section headed **Schedule**, the first paragraph has been amended to read:

"Civil sanctions that may be issued for non-compliance include fixed monetary penalties of £200 or £100 if paid within 28 days (added by a later amendment), compliance notices, third party undertakings and enforcement undertakings. A monetary penalty may be issued where a person fails to comply with a compliance notice or a third party undertaking."

The third paragraph now reads:

"Regulators may recover the cost of enforcement in the case of fixed monetary penalties, compliance notices and stop notices."

#### Packaging Waste (Data Reporting) (England) Regulations 2023

In this entry, immediately before the section heading **Part 1: General (Regulations 1 to 14)**, the following new paragraph has been inserted:

"The Packaging Waste (Data Reporting) (England) (Amendment) Regulations 2023, Packaging Waste (Data Reporting) (Scotland) Amendment Regulations 2023 and the Packaging Waste (Data Reporting) (No. 2) (Amendment) Regulations (Northern Ireland) 2023 corrected minor errors and omissions to the principal regulations."
