Don't worry – all the amendments noted here have been made to RRC digital and downloadable publications.

NEBOSH Resources

If you are studying for a NEBOSH qualification, we would like to remind you that guidance from NEBOSH is available in the following publications, which can all be accessed from the 'Qualifications' area of the NEBOSH website (under 'Resources' for each relevant qualification):

Guidance on command words used in learning outcomes and question papers – Certificate qualifications
 This gives definitions of command words and example responses to everyday scenarios and typical exam questions.

(Note: not relevant to Units NG1, IG1, NGC1, IGC1, NC1, IC1, FSC1 or EMC1.)

• Guidance on command words used in learning outcomes and question papers – Diploma qualifications

This gives definitions of command words and example responses to typical exam questions.

(Note: not relevant to Units ND1, ID1, ND2, ID2, ND3 or ID3.)

• Sample New-Look Question Papers

These show the current format for paper-based, invigilated exams at Certificate level. They are no longer divided into sections but still contain one 20-mark question and ten 8-mark questions.

(Note: not relevant to Units NG1, IG1, NGC1, IGC1, NC1, IC1, FSC1 or EMC1.)

• NEBOSH Open Book Examinations: Learner Guide

This gives guidance on the new Open Book Examinations for Certificate Units NG1, IG1, NGC1, IGC1, NC1, IC1, FSC1 and EMC1.

(Note: not relevant to any other Certificate units.)

• NEBOSH Open Book Examinations: Learner Feedback

This uses the August 2020 Open Book Exam as an example. It gives advice on the kind of answers that would attract marks and those that would not and guidance on how to approach similar questions that you could expect to see in future papers.

(Note: only relevant to Units NG1, IG1, NGC1 and IGC1.)

• Diploma Digital Assessment: Learner Guide

This gives guidance on the new digital assessments for Diploma Units ND1, ID1, ND2, ID2, ND3 and ID3.

(Note: not relevant to any other Diploma units.)

We strongly recommend reading the guidance referred to above that is relevant to the units you are studying, as part of your preparation for the exams.

RRC Health and Safety Law and Case Law Guide

We have updated the Health and Safety Law and Case Law Guide in relation to some recent legislation. If you are studying a national (UK) course, please note the changes below.

Health and Safety at Work, etc. Act 1974

We have made two additions to this entry.

Under the subheading Section 9: Duty Not to Charge Employees for Things Done or Provided Pursuant to Certain Specific Requirements, the following has been added:

"The **Personal Protective Equipment at Work (Amendment) Regulations 2022** have modified this section such that the duty placed on the employer by this section now applies to their workers, and 'employer', as referenced in this section means the person by whom the worker is employed under their worker's contract. An amendment was also made to s52 of this Act, to update the meaning of 'work' and related expressions."

At the end of the entry, the following new subsection has been added:

"Section 52: Meaning of Work and At Work

- (1) For the purposes of this Part:
- (a) 'work' means work as an employee or as a self-employed person;
- (b) an employee is at work throughout the time when he is in the course of his employment, but not otherwise; (bb) a person holding the office of constable is at work throughout the time when he is on duty, but not otherwise; and
- (c) a self-employed person is at work throughout such time as he devotes to work as a self-employed person; and, subject to the following subsection, the expressions 'work' and 'at work', in whatever context, shall be construed accordingly."

RRC Environmental Law and Case Law Guide

We have updated the Environmental Law and Case Law Guide in relation to some recent legislation. If you are studying a national (UK) course, please note the change below.

Environment Act 2021

The first paragraph of this entry has been amended to read as follows:

"This is a voluminous Act that covered 279 pages on its introduction. It is very much a framework Act which for some requirements to be implemented will require the introduction of secondary legislation. Various parts of the Act become law following the issue of commencement regulations while others are immediately law or become law two months following passing. For example, the **Environment Act 2021 (Commencement No. 1) Regulations 2021** introduced Schedule 1 (the introduction of the Office for Environmental Protection) and the **Environment Act 2021** (Commencement No. 2 and Saving Provision) Regulations 2022 introduced Sections 1 to 7 covering environmental targets. A summary of the Act is provided below."
