If you are studying for a NEBOSH qualification, we would like to remind you that guidance from NEBOSH is available in the following publications, which can all be accessed from the 'Qualifications' area of the NEBOSH website (under 'Resources' for each relevant qualification):

NEBOSH Scenario-Based Assessments: Guidance for Learners

This provides guidance on Scenario-Based Assessments for NEBOSH qualifications. It gives examples of extracts from past scenarios, types of questions and how marks would be awarded for answers.

Terminology

An Update on Use of the Term "Incident"

In the world of health and safety the terms 'accident' and 'incident' can have different interpretations.

In the HSE's publication HSG245 *Investigating accidents and incidents*, the section entitled **Understanding the language of investigation** provides an interpretation of an 'adverse event' as:

- an accident, which is "an event that results in injury or ill health"; or
- an incident, which is a "near miss" or "undesired circumstance".

In the ISO standard ISO 45001 Occupational health and safety management systems, an incident is interpreted as:

"occurrence arising out of, or in the course of, work that could or does result in injury and ill health".

NEBOSH have declared that they will use the ISO 45001 interpretation in their assessments. For scenario-based exams, the scenario often makes it clear what type of incident it is. For example, the worker fell from the ladder and broke their arm - it's clear that this 'incident' has resulted in harm to the worker.

The interpretation provided in ISO 45001 does not directly address 'damage' (to property); for example, a forklift truck striking a roller shutter door. NEBOSH have therefore adopted an approach to a description of 'incident' which includes damage. The approach (interpretation) provided by NEBOSH is:

"An event that happens in the workplace that causes (or has the potential to cause) harm, injury, ill-health or damage."

In some cases, the word 'accident' will be used because that's the title given in a particular piece of research, for example 'Reason's model of accident causation'.

If in doubt or you need further clarification, please contact your tutor.

Assessment Terminology

NEBOSH use the following terms in relation to their assessments - we thought it would be useful to clarify what RRC see these as, so we can put your mind at ease, as it could be a little confusing:

- **Digital assessment:** the way the assessment is delivered and completed is entirely electronic, meaning you download the assessment paper and submit it electronically using the NEBOSH platform.
- **Scenario-based assessment:** this is the style of the assessment. It uses a scenario which you need to read, refer to and rely on when answering the questions/completing the tasks in the paper.
- **Open-book exam:** this is the format of the assessment. An open-book exam, as you know, allows you to refer to resources and notes while you are completing the paper.

RRC Environmental Law and Case Law Guide

We have updated the Environmental Law and Case Law Guide in relation to some recent legislation. If you are studying a national (UK) course, please note the changes below.

United Kingdom Withdrawal from the European Union

In this entry, references to 'retained EU law (REUL)' have been changed to 'assimilated EU law'.

Deposit Scheme for Drinks Containers (England and Northern Ireland) Regulations 2025

Environmental Protection Act 1990

In this entry, under the subheading **Sections 45 to 48 and 51 to 61: Collection, Disposal or Treatment of Controlled Waste**, the following new paragraph has been added:

"The **Separation of Waste (England) Regulations 2025** amend parts of section 45 of the Act such that any combination of the recyclable waste streams metal, glass and plastic may be collected together. They also allow for the mixed collection of household food and garden waste. Exemptions exist for micro firms (those employing less than 10 full-time equivalent employees) from the requirements of sections 45AZA and 45AZB (covering waste separation) until 31 March 2027."

European Union (Withdrawal Agreement) Act 2020

In this entry, under the subheading **Relationship to EU Law**, the last paragraph has been amended to read:

"On IP completion day, existing EU law that is applicable in the UK will be converted into 'Retained EU law' (this is now known as assimilated EU law) and historic European Court of Justice decisions will be domesticated. After IP completion day, it will be possible to decide whether to depart from any assimilated EU law."

Transfrontier Shipment of Waste Regulations 2007 (as amended)

In this entry, under the subheading Introduction and Amendments, the third paragraph now reads:

"As the source of the law is an assimilated European Regulation it does not require transposition into UK law as such. UK Regulations are required, however, to create competent authorities, offences and penalties."
